**Sub : AIBPARC, West Bengal State Committee holds its
3rd Triennial General Body Conference at Kolkata on 18th April, 2022
in the midst of enthusiasm and participative involvement of members and affiliates.**

We have much pleasure to inform that 150 Delegates and Observers from different affiliates of the state and also the members of the Governing Council stationed in West Bengal participated in the said conference with interest and involvement. This was a real pleasure to see that as many as 25 speakers participated in deliberations on the report of the Secretary and the resolutions placed in the house. At the end of the day, the house got enriched by the collective wisdom of the delegates and observers. Members expressed serious anxiety about the delay in updation of pension and exorbitant premium of health insurance. Representatives of some of the banks expressed concern for the disservice of the TPA. The house assured the leadership that for resolve of the long pending issues of pensioners and for getting formal consultative status for the organisation of Retirees, the members were fully prepared to come out on the streets and demonstrate their anger and anguish against the decision makers. The house was unanimous in waging struggle against proposed moves of privatization and also bringing any kind of legislation by which the safety and security of common man's fund will be jeopardized.

At the end of the day, the state committee for the term April, 2022 to March, 2025 was formed unanimously. The resolutions placed before the house (10 in number) was increased by another one and the same was on immediate implementation of improved family pension in Regional Rural Banks. The report of the Secretary, the accounts for 3 years and the resolutions got full approval of the house. The entire list of office bearers will be published soon among the affiliates of the state.

Com. Tridib Charan Choudhury (UCO Bank) and Com. Suprita Sarkar (e-UBI) have been re-elected as President and Secretary of the state committee. We congratulate all the newly elected office bearers and hope that the state committee will move from strength to strength in days to come.
