Sub: Meeting of the IBA standing Committee on HR on 24th April, 2023.

We came to know from your letter HR &IR/MBR/HR Com dated April 17,2023 that a meeting of the above committee is scheduled to be held on 24th April, 2023 to discuss the "Medical insurance scheme". This is obvious that the discussion will also take place on Group medical insurance scheme for Bank Retirees. You are well aware of the fact we have represented before you time and again the need to talk to the apex level Retiree organizations on issues pertaining to Retirees. As you did not take into cognizance the very reasonable demand of the Retirees, it is no doubt, a disquieting development.

2. We have sent our views in detail on GMISR to you by our letter no: AIBPARC/IBA/GMISR/Email/2023 dated 22nd March,2023.We are once again sending a copy of the said letter as an enclosure with the request to consider our views with sympathy

and favour. It is the need of the hour to save the community of Retirees from the exorbitant financial burden to pay the annual premium without making qualitative and / or quantitative degradation of the existing terms and conditions. The employers will have to come forward with full subsidization as already done in cases of various segments mentioned detailed in the letter.

3. Notwithstanding whatever has been said in the letter enclosed, we lodge our demand to have (1) immediate discussion with apex level Retiree organizations to know their views on GMISR, (2) not to make any qualitative and quantitative degradation of the existing terms and conditions (3) to follow the directives of DFS as contained in advisory dated 24.02.2012 in letter and spirit and to (4) evolve a Retiree -- friendly policy/ scheme which has a human touch to the senior citizens.
