3. The Committee will meet the representatives of the Award Staff Unions and Officers Associations separately on 22nd July, 21. We hail the move and consider it a big leap forward. We shall have positive hope that it would mark the beginning of an exercise which is long awaited for the Retirees who are languishing for decades because of non-revision of Pension which got frozen on the date of superannuation.

4. We shall be demanding before IBA and different components of UFBU that the issue of improvement in Family Pension should be clinched first since it was documented in MOU on 22nd July, 20 and by coincidence, the present meeting is taking place on 22nd July, 21 i.e., on the day of first anniversary. We are in touch with all concerned to convey our feelings and we hope that our anxiety in this regard would be taken care of.

5. We shall be re-iterating our stand conveyed earlier to IBA that AIBPARC and other Retirees organisations should also be called to hear their views. This is urgent.
