**Sub : AIBPARC JHARKHAND STATE COMMITTEE HOLDS 3<sup>RD</sup> TRIENNIAL GENERAL BODY  
CONFERENCE AT RANCHI ON 9<sup>TH</sup> JUNE, 2019 IN REAL COLOURS.**

We have pleasure to inform members that AIBPARC Jharkhand State Committee organized its 3<sup>rd</sup> Triennial General Body Conference at Vivekananda Vidya Mandir, Ranchi on 9<sup>th</sup> June, 2019. The meeting, presided over by Com. S.K. Sinha was attended by more than 200 pensioners and retirees including 15 lady members. The highlights of the conference are reported in brief :

- The presidium comprised of Com. S.K. Sinha (PNB), Com. S.K. Majumdar (Allahabad), Com. P. Tirke (BOI), Com. A.K. Sinha (Allahabad), Com. D. Sengupta (BOI) and Com. S. Sarkar. The AC Hall of the Vidya Mandir was packed to capacity at 10-30 a.m. The conference started with the opening song of Com. Malay Chanda and lightening of lamp by the leaders. Welcome address was read out by the Chairman of the Reception Committee.
- Com. D. Sengupta submitted written report of the Secretary, Resolutions and other relevant papers for consideration of the house. The Treasurer placed accounts for 3 years. It was encouraging to see that 12 members participated in deliberations. They spoke on all the issues concerning the interest of pensioners and wanted a speedy disposal of the demands because time at the disposal of the retirees was short. The reply of secretary being heard, the house unanimously approved the report, accounts, resolutions and other relevant papers.
- Com. S. Sarkar, General Secretary in his hour long speech elaborated the present situation prevailing in the industry, the legal decisions which brought relief to retirees in last few years, the initiatives taken by AIBPARC/CBPRO jointly with AIBRF for resolving the core issues like updation, family pension, group medical insurance etc., different court cases on gratuity and special allowance not being computed in calculation of superannuation benefits, talks organised by AIBOC with different organisations etc. He also pledged that the organisation in next few months would not leave any stone unturned to see that the issues are resolved.
- The last item of agenda was holding of elections for next 3 years. The house unanimously passed the panel of names. Com. S. Bara (PNB) was elected as the President and Com. D. Sengupta was elected as the Secretary of the unit. The thanks-giving was done by Com. Lalita Karketta. At the end of the programme, there was a medical awareness session conducted by a Ranchi-based medical organisation.

AIBPARC congratulates the team of newly elected office bearers and hopes that under the new leadership, the organisation would move from strength to strength in this part of the country.
