**Sub : Sending of memorandum by members of the Governing Council to Hon'ble
Union Finance Minister, Secretary, DFS, MOF, GOI and Chairman, IBA
on various unresolved issues of Bank Pensioners and Retirees.**

A reference may please be made to our circular no. 39-22 dated 11th July, 2022 wherein we informed that the members of the Governing Council would individually send the above memorandum to various authorities within 15th to 30th July, 2022. We have already received physical and virtual confirmation of sending the mail by several GC members. **We now request the Secretaries of all our affiliates to have a last minute check up as to whether all the GC members from the respective affiliates have sent the emails. In case, a few is left out, the compliance may please be made 100% within the scheduled period i.e. 30th July, 22.**

Considering the present situation, **we have taken the decision that similar such memorandum will be sent by members of all our affiliates in the first and second week of August, 2022.** As it requires some arrangement to be made for booking of number of emails and other formalities, we may require few days time to declare the programme open. **We shall try our level best to get it operative from 1st August, 2022.** Before that date, the copy of the memorandum and process to be followed will be advised in detail. Affiliates are requested to sensitize the membership beforehand so that we can achieve stupendous success as we had in the previous occasion.

In pursuance of the decision of the GC, we are expecting that the dates for demonstration in State Capitals and the national capital will also be made known to members after 15th August, 2022. We are taking some time to declare the dates because we like to ensure that the programmes are not disturbed by climatic conditions. The weather is an important aspect which we are to keep in mind. The details of all programmes will be advised well ahead so that members do not have any problem to organize.
