Respected Sir,

Sub: Group Medical Insurance Scheme for Bank Retirees for the year November 21 to October 22.

We submitted a comprehensive paper on the above subject before your good self on 21st July 2021 which addressed all conceivable aspects of the scheme affecting the interest and welfare of the Retirees. We can reasonably expect that IBA has considered the suggestions with sympathy and favour.

We are expecting that the final round of discussion between IBA and the Insurance Company will be initiated soon on the terms and conditions of the Policy for the current year. This is high time for us to request you on behalf of the community of Bank Retirees to kindly see that :

* The annual premium remains restricted within an affordable amount by full/substantial Subsidization by Banks.

*IBA should take up with MOF, GOI for waiver of the GST component for which we have been continuously striving.

Sir, You will surely appreciate that the Bank Retirees are already in the midst of a grim situation because of excessive increase of price of essential commodities including cost of medicine.

A compassionate view about the affordability of premium is needed so that more number of Retirees do not go out of the cover of group medical insurance policy under compulsive situation.
