Sub: Revision of Pay and Allowances of Regional Rural Banks' (RRBs) employees under Proviso 2

of Section 17(1) of the Regional Rural Banks Act, 1976-regarding.

Madam(s)/ Sir(s),

In exercise of the powers conferred under second proviso of Section 17(1) of the Regional Rural

Banks Act, 1976, the Central Government, consequent upon the revision of the wages / pay structure of

the workmen / officers' employees of the Public Sector Banks (PSBs) in terms of the 12th Bipartite

Settlement / 9th Joint Note, conveys approval for payment of ad-hoc amount / on ad-hoc basis in line with

the said settlement / Joint Note, pending amendments to the relevant regulations, of-

(i) revised salary, allowances and arrears thereof to serving officers and employees of RRBs at par

with PSBs w.e.f. 01.11.2022.

(ii) revised pension and arrears to existing pension optees in RRBs, retired w.e.f. 01.11.2022, and

(iii) monthly ex-gratia along with pension, not attracting any other allowance for pensioners and family

pensioners [eligible for pension on or before 31.10.2022] as an one-time measure for the current bipartite

period.

2. The RRBs may issue an order indicating the revised pay scale in respect of each category of

employees after seeking the approval of their Board of Directors.

3. A copy of the order issued in this regard may be endorsed to this Department as well as to

NABARD for information and record.
