**Sub : UFBU meeting held on 12<sup>th</sup> November, 2021.**

We like to inform our members that a meeting of UFBU was held at Mumbai on 12<sup>th</sup> November, 2021. Representatives of all the 9 Constituents attended the meeting. A detailed circular UFBU/2021/16 dated 15.11.21 has been issued. The relevant points are being reported hereunder for information :

- Members have been asked to carry on the campaign and struggle against attempts of privatization of banks. The programmes in brief are : Mass Petition to Prime Minister and Signature-Collection Campaign; Dharna in all states between 29.11.21 and 4.12.21 depending upon local convenience; Dharna before Parliament by UFBU leaders on a date to be finalized and strike actions to be declared on the day of Dharna.

- The meeting deplored the attitude of the management of CSB in denying legitimate wage revision to the employees and officers of the bank and initiating vindictive measures. The meeting also discussed the problems persisting in LVB. The meeting demanded adequate recruitment of manpower in Banks.

- Although one year has elapsed after signing of Bipartite Settlement, the meeting noted that several issues are yet to be resolved and queries of banks are remaining pending with IBA.

- **In the same way, discussions have not made any headway on the important issue of updation of pension. There are also other issues related to Pension Scheme which need further discussion. The issue of repeated higher premium on medical insurance policy for the retirees years after years also needs to be discussed with IBA but the meeting observed that IBA has been adopting a non-serious approach on these issues.**

- **It was decided that the leaders of UFBU will meet the Chairman of IBA at the earliest to discuss expeditious resolution of the following issues :**

(1) All residual issues (2) **Updation and other Pension related issues** (3) **Medical Insurance Scheme for retirees** (4) FAQ to issues referred by Banks on wage settlement.
