Dear comrade,

**Sub: Proposed centralised Dharna at Delhi.**

1. In our earlier communication CBPRO/06/24 dated July 14,2024, we declared several action points which included, inter alia, the holding of a centralised Dharna at Jantar Mantar, Delhi in the month of September,2024.

2. In the present situation, we have taken stock of the following factors which are very important in the decision - making process:

**(A)** The Hon'ble Union Finance Minister and the officials of the Finance Ministry, Government of India were busy with the Budget session which has just been over and Adjourned Sine Die.

**(B)** There is a strong possibility that the final hearing of the Singla case might come up before the Supreme Court at any time in the month of August/September, 2024 and the outcome of the lengthy judicial proceeding has a far-reaching consequence on all concerned.

**(C)** During the months of September and October 2024, there are a good number of festivals all over the country, which we shall have to avoid.

3. Keeping all such issues in mind, we propose to hold the Centralised Dharna at Delhi on a convenient date between 17th to 27th October, 2024 subject to permission of Police Authorities. We have advised our leaders stationed at Delhi to approach the Police Authorities for requisite permission. The moment it would be made known, we shall issue formal communication so that the Constituents of CBPRO make necessary preparations to ensure largest participation by Bank Pensioners and Retirees.
