Sub: "Dharna" of Bank Pensioners & Retirees at Jantar Mantar, Delhi on 22nd February, 2024 (subject to Police permission) under the banner of CBPRO demanding implementation of Updation of Pension and computation of Special Allowance for calculation of Pension.

We like to convey that the President, the Working Presidents, the Advisor, the General Secretary, Bengaluru-based Senior Leaders, special invitees, and Bengaluru based leders of CBPRO met at a meeting in Bengaluru on 10th January, 2024 to take stock of the situation in regard to Pension Updation at the post-MOU (between IBA & UFBU) signing phase. After prolonged deliberations, following decisions were taken:

*A massive "Dharna" will be organized at Jantar Mantar, Delhi on 22nd February, 2024 under the banner of CBPRO demanding implementation of Pension Updation and computation of Special Allowance for calculation of Pension.
