Dear Comrade,

Sub: 2 Days continuous strike in the Banking Industry on 24th&25th March,2025 at the call of UFBU on various pending issues.

Ref: UFBU Circular no 2025/1 dated 07.02.2025.

Members have already known by this time that UFBU declared different agitation programmes culminating in strike actions for two consecutive days as mentioned above on various demands as detailed out in the aforesaid circular.

We extend our support to the agitation programmes as the demands are pertinent, important, and relevant in the context of Work--Life Balance of Banks' Workforce, Rising Unemployment, Adequate Recruitment, Resolution of Long Pending Residual Issues, Application of Good Corporate Governance Philosophy in the Management of Banking Activities and Industrial Relationship.

Here, we wish to mention two issues in particular -- the resolution of Residual Issues pending before IBA which include, inter alia, several unresolved demands of the Retirees and also the demand for recruitment in all cadres which is an abject necessity.

Though the Issues relating to Pensioners and Retirees mainly in respect of Pension Updation as provided in the Pension Settlement 1993 and Pension Regulation, Review of Exgratia, Uniform of DA to All Bank Pensioners without discrimination, could have been also specially emphasized in the UFBU Communication announcing their Action Programmes, we hope that during the Agitation Programmes, the UFBU will highlight the issues concerning the Bank Pensioners and Retirees in a concerted way during their Action Programmes.

We also wish to convey our thanks to those Constituents of UFBU who in their separate communications regarding the Demands and proposed Action Programmes have also highlighted their Resolve to fight for the resolution of the burning issues of Bank Pensioners and Retirees. We expect UFBU will collectively show their full Sensitivity in regard to the serious grievances of their Former Colleagues who built their Organisations during their Service tenure.

We call upon our members to take part in the protest in all the demonstrations and the rallies and extend our Strong Fraternal Support to our Younger Colleagues of the Banking Industry in their Fight for Justice for their Members, their Former Colleagues and for the well-being of the Banking Industry which is the Main Economic Arm of the Nation.
