Sub: Exemption of GST on health insurance premium - update on the Court case pending before the Hon'ble High Court of Kerala at Ernakulam.

We report here under the message received from our Advocate which is self-explanatory.

## **QUOTE**

"Our cases came up today. National Insurance Company had filed counter affidavit day before yesterday itself. They insisted that the interim order be vacated immediately since they risked the liability of GST. We strongly objected to their pleadings.

The Court did not accede to the Insurance Company's demand, but directed us to submit undertaking to the effect that we are liable to pay the GST amount if the case went against us. We have agreed to it.

The Court has directed all respondents to file counter affidavit as soon as possible. The case is posted on 15/11/2025"
