Sub: Updates on the case pending before the Hon'ble High Court of Kerala at Ernakulam in regard to the exemption of GST on Health Insurance Premium.

We have received the following feedback from our Advocate:


The GST case will not come up for hearing on 15th November, 2025. Along with that, similar petitions by our Affiliates/Individuals and other Organisations filed in the Hon'ble High Court of Kerala also will stand posted to a future date.

He had a discussion with our President on the Rejoinder to the Counter Affidavit of the Insurance Company. It was also made known that the Counter Affidavits have not been filed so far by the other Respondents. He would advise us soon about the next date of hearing.
