To all Constituents of CBPRO:

Dear Comrade,

**Sub: Organizing Dharna programmes at different state capitals to sensitize the membership at ground level for ensuring an ever-largest gathering at the centralized Dharna proposed to be held at Jantar Mantar, Delhi on 23rd October, 2024.**

1. The Constituents and the membership at their folds have already been apprised by the earlier circular CBPRO/09/2024 dated August 16, 2024 that a centralized Dharna will take place at Jantar Mantar, Delhi on 23rd October, 2024 at the call of CBPRO to demand immediate resolution of the long pending issues of Pension Updation, Computation of Special Allowance for the purpose of calculation of gratuity and pension, Health Insurance at affordable cost, restoration of the Commuted Value of Pension after 10 years, Consultative status for Apex Level Retiree Organisations to sort out the issues affecting the interest of the Retirees.

2. We are happy to see that the Constituents of CBPRO have already advised their organisational tiers to take effective preparation for organizing a massive gathering on the above stated date and venue. In the present context, it has also been felt a necessity to organise state level Dharna at capitals/ important centres to sensitize the membership at the ground level to ensure ever largest gathering at Delhi on 23rd October, 2024.

3. We have noted with satisfaction that the CBPRO, Karnataka unit, in a recent meeting at Bengaluru has taken the decision to organise a Dharna programme at Bengaluru on 23rd September, 2024 (just one month ahead of the centralised Dharna at Delhi on 23rd October 24) to sensitize the membership at ground level for a large-scale participation at Delhi. Similarly, the other state units are being requested to explore the possibility of organizing such programmes in as many centres as possible under the banner of CBPRO. The leaders stationed at each centre are requested to contact the leaders of different constituents of CBPRO and try to form a small committee of CBPRO at state level and advise the central body about the names and contact details of such persons for record.

In such meetings, the issues can once again be explained in details and appeals may be made to each participating unit to take such steps as to mobilize largest segment of members from different parts of the country in general and specially from Delhi and adjoining states in the centralized Dharna at Delhi.

**March on to Delhi on 23rd October, 2024 with the demand of resolution of all the long pending issues of the Bank Retirees.**
