I am sending the trail mails about the updation of Pension in Banks. My rejoinder dated 11.7.2022 to the reply from Department of Financial Services, Ministry of Finance, New Delhi was forwarded by your Office when Shri Anil Bhatia was looking after the same in the month of July 2022. It was expected that the secretary, DFS would respond by 13th August or so. But in spite of a lapse of more than five months, nothing is heard from their end or from your end.

Sir, you will appreciate that people like me being the senior and super senior citizens are fighting against all odds to get their legitimate demand of updation of pension realised despite the fact that Bank Employees Pension Regulations 1995 have clearly provided for the updation vide Regulation No. 35(1) which is reproduced hereunder for your ready reference;

Quote

Basic Pension and Additional Pension, wherever applicable, shall be updated as per the formulae given in Appendix-I.

Unquote

I would like to submit that in absence of the response from DFS, Ministry of Finance, a cognizance of the maintainability of my petition may please be taken and suitable orders passed based on the available evidence to redress the long pending grievance of the Petitioner.
