**Sub: 5th Triennial General Body Conference of AIBPARC to be held at
Ernakulam on 28th & 29th April, 2026.**

Ref: (1) Notice issued on January 23, 2026 through circular no 07-26.

(2) Further clarification conveyed on the number of Delegates and Observers through circular no 08-26 dated January 24, 2026.

1. Different Affiliates of the organization have brought to our notice that the willingness of members to join the GB is very encouraging and it is difficult for many such affiliates to manage the level of aspiration of members within the ceiling of the number of Delegates fixed at 30 as per the present provisions of the Rules and Regulations of the society.

2. Affiliates / Members may please appreciate that the earlier maximum ceiling stood at 20 which was amended in the General Body conference at Chennai on 30th & 31st March, 2019 and the figure was raised to 30. In view of the increasing membership of different affiliates, we may have to increase the number further by way of an amendment to the Rules & Regulations for which a separate notice will be issued. In other words, we shall have to work within the present ceiling of the number of Delegates at 30 so far as the 5th GB is concerned.

3. Considering the level of aspiration of members to be a part of the 5th Triennial General Body Conference, a decision has been taken that the ceiling of Observers which was earlier communicated to be 50% of the total number of Delegates may now be raised to 100% of the total number of Delegates. In other words, the number of Delegates which is permissible for an Affiliate will remain the same till amendment to Bye Laws is done. **But however, the number of Observers is increased to the same as the number of Delegates.**

4. A small correction in point no.1 of circular no.08-26 dated 24.01.2026 may please be noted. It was stated, inter alia, "For this purpose, membership less than 50 shall be ignored and above 150 shall be taken as 200." **It may be read as: "For this purpose, membership less than 150 shall be ignored and above 150 shall be taken as 200."**
