Sub: Meeting called by the Secretary, DFS, MOF, GOI.

We are happy to note that the Constituents of UFBU very rightly expressed the serious concerns of the Working Class of which the serving Employees and Officers of the Banking Industry and we as Citizens of the Nation are an integral part. You also rightly pointed out during the meeting the necessity to have a regular arrangement of discussions with the Central Trade Unions about the provisions and impact of the New Labour Code and insisted on creation of permanent job opportunities in the country.
