- 1. Rs. 6000/- will be given to those who are opting for IBA's GMISR.
- 2. Rs.3000/- will be given as medical reimbursement for all others.
- **3.** A new scheme for funeral expenses for Retirees will be introduced where Rs. 10,000/- will be paid to the legal heirs/ spouse in the event of the death of the Retirees.
- \*This is pertinent to mention that the above issues have been regularly pursued by CBROA & GS, CBOA has also regularly followed them up with the management for arriving at a successful resolution.
- \* CBROA felicitated 66 persons who attained the age of 75 years plus.
