Sub: The Pension Updation case pending before the Hon'ble Supreme Court.

At the outset, We wish to categorically clarify that the M C Singla case had not come up for final hearing in the last week daily list.

However, we have requested the Petitioners and their Advocate to file Application for Early Hearing so that the Hearing Proceedings take place leading to Delivery of Judgement.

We feel sad to find in the social media fake and mischievous messages by certain elements creating deliberate confusion in the matter aggravating the agony and anxiety of members. Those elements are also twisting the whole issue by giving their own Interpretations to get undue publicity and thereby causing damage to the cause of Bank Pensioners.
