Dear Comrade,

Bank Pensioners' and Retirees' MAHA ABHIYAN --MEGA CAMPAIGN FOR JUSTICE.

Sub: The first phase of the agitation programme – the participation of members in the submission of On-Line Memorandum starts with a bang – First 24 hours witness flooding of email Memoranda, choking the link provided – the organizational hierarchy needs further stepping up of activities to make the CBPRO/AIBPARC campaign a legendary one.

- 1. We are happy to note that the leaders, veterans, activists and members of AIBPARC and Constituents of CBPRO have swung into action instantly on receipt of CBPRO circular being reproduced by us through our communication no. 12-25 dated 21.02.2025.
- 2. Members are aware that such windows for participation do not remain open for an indefinite period. By all likelihood, as in previous occasions, it may remain open for a period of 15 days i.e. upto the evening of 08.03.2025. So, there is an urgency to sensitize the entire membership, irrespective of cadre, organizations they belong to, right from the Retired Chairmen to the Junior most Pensioners and Retirees of the Banks on a priority basis to take part in the programme.
- **3.** All our affiliates, state committees, leaders, activists and veterans are once again being requested to ensure the initiation of the following steps:
- **(A)** The circular of CBPRO being reproduced by AIBPARC should reach the ground level of each Affiliate Organization. As the WhatsApp groups are very important tools for communication, the circular should be posted in all the operative groups.
- **(B)** The tiers of different organizations are required to make a follow up in an intensive manner to take stock of how many members have already participated and how many are yet to do the same. Personal contact may please be done with such members so that the participation level becomes total or near total.
- **(C)** There have been certain members who do not use smart phones and they are not so techno-friendly to handle the job. The local leaders of the organization will have to

come forward to help such persons.

4. Members are requested to route the sending of mails through the website of AIBPARC. The process has been clearly spelt out in point number 5 (a), (b)and (c) of CBPRO circular 02-2025 dully reproduced by AIBPARC in circular no. 12-25. This is being insisted upon because such sending through our website gets recorded and the exact figure is readily available from the website manager. If it is sent through a separate

link, it does not come into the reckoning of the organization. It seems some affiliates have in their enthusiasm to facilitate large scale participation taken recourse to their own other links with a view to make still simpler clicking. But we wish to state that the CBPRO has made the procedure as simple as possible and moreover if all Pensioners and Retirees follow the link provided by CBPRO, we can get the exact consolidated number of Memorandums when the present exercise gets over.

5. Members are to appreciate that struggle for the right cause is an unending process and CBPRO/ AIBPARC are in the midst of it. Once when the campaign in the form of On-Line Memorandum ends, the second phase of sending uniformly drafted letters to all the Members of the Parliament by individual member will start and continue for nearly a month. Simultaneously or after it, the holding of protest demonstrations at more Centers will be organized. The proverb says: "Morning shows the Day." If we can record stupendous success in the first programme, the wheel of triumph will roll automatically.

We call upon all the Bank Pensioners and Retirees to make this First Phase of Bank Pensioners and Retirees MAHA ABHIYAN --MEGA CAMPAIGN FOR JUSTICE, a Stupendous Success in making Our Voice and Cry for Justice is Heard and Rightly Acted upon by the Highest Authorities of the Government and the Nation.
