Sub: Holding of the 2nd Triennial Conference of Jharkhand State in the midst of enthusiasm.

AIBPARC, Jharkhand State Unit held its 2nd Triennial Conference on 19th June, 2016 at Ranchi. 150 members from 7 affiliates of the state attended the conference. The elder citizens came from different parts of the state and displayed remarkable enthusiasm to make the conference an all out success.

Com. S. Sarkar, Joint General Secretary, Shri Sudipto Mukherjee, General Manager, Bank of India, SLBC, Com. S.K. Pathak, Secretary, AIBOC State Unit and Com. J.P. Lala of SBI Pensioners' Association remained present in the conference and greeted the participants.

Com. Debasis Sengupta, Secretary, Jharkhand State Unit of AIBPARC narrated in details the activities of the State Committee in respect of consolidation of retirees in the state. He also talked on the possibilities and problems faced by the organisation of retirees. Different members participated on the written report of the Secretary and offered various suggestions. The issues raised by the members and the queries made by them were addressed properly by the Secretary. Different resolutions on the demands of members including the discrimination meted to the retirees of RRBs were accepted by the house.

Shri Sudipto Mukherjee, General Manager, Bank of India, conveyed his good wishes to the retirees and assured of all reasonable cooperation. Com. Pathak, State Secretary, AIBOC, assured all help and cooperation to the State Unit of AIBPARC. Com. J.P. Lala expected that CBPRO would usher in a new era of hope for the bank retirees of the country. Com. Suprita Sarkar, narrated in detail the initiatives taken by AIBPARC with Union Government and IBA on a continuous basis to highlight the issues of the retirees and to achieve the demands. He also informed different demonstrative programmes undertaken by the organisation at different points of time. He insisted on total coordination among all the retiree organisations of the country and appealed to Government and IBA for displaying greater sensitivity. He demanded quick resolve of at least 3 priority issues – reimbursement of domiciliary expenses, removal of discrimination on payment of DA and improvement in family pension.

The house unanimously adopted a panel of names who would be leading the state committee for next 3 years. Com. R.B. Singh (PNB) and Com. Debasis Sengupta (BOI) have been elected as the President and the Secretary of the state unit respectively. We congratulate both of them and also the new team of office-bearers. We fervently believe that the holding of the conference will further consolidate the retirees movement in this part of the country.
