Dear Comrade

Sub: Our affiliate at erstwhile Allahabad Bank organized their 3rd Triennial conference and General Body meeting at Delhi on 5th April,2023.

We have pleasure to convey that the above conference was held at Constantia Hall, YWCA, New Delhi. Delegates and observers from different parts of the country attended the General Body Conference.

Com. D.K. Thusoo, Chairman, Reception Committee, welcomed all dignitaries and guests. **Com Sudhir Verma**, President, expressed the hope that the conference would further strengthen the family bonding that exists in the greater family of (e) Allahabad Bank Retirees. **Shri Rohit Joshi**, CGM, Indian Bank, assured every type of co-operation to solve the problems of Retirees which fall under his domain. **Com. S. Sarkar**, GS, AIBPARC, elaborately explained the stand of the organisation on all the identified issues and specifically demanded implementation of Regulation 35(1) Appendix-1 with its amendment upto 2003 by IBA with immediate effect. **Com J.D. Sharma**, Vice President, AIBPARC, explained in details the contents of the correspondence exchanged between him and the government department on pension updation. He also observed that the cost of updation is not at all astronomical as being claimed by a section but it is within manageable limit. **Com R.N. Shukla**, President, All India Indian Bank Officers Association expressed anguish at the negative attitude of IBA and Government towards the demands of Retirees. He also demanded a fair deal for the Retirees of e Allahabad Bank Retirees. **Com. R L. Gupta**, General Secretary, read out the greetings sent by **Com. K.V. Acharya**, President, AIBPARC. He then described the initiatives taken by the organisation with the management of Indian Bank to resolve various issues confronting the Retirees and also told how the organisation could break the ice in certain cases. He hoped that dialogue at national level would bring some improvement in the Group medical insurance scheme for Bank Retirees. **Com K.P. Rai**, Chairman, proposed vote of thanks and urged upon larger co- ordination in the organisation.

After a break, the House re-assembled in the Business Session and transacted the normal agenda items. **Com. Balmukund** and **Com R.L. Gupta** have been elected as President and General Secretary respectively. We congratulate the team of office bearers.
