**Sub: Our affiliate at Central Bank of India held its 3<sup>rd</sup> Triennial General Body Conference at Bhopal on 10<sup>th</sup> March 2024 in style, grandeur and in the midst of massive participation.**

The principal highlights of the General Body Conference are reported hereunder for information of members:

- 1) The conference held at “**Samnvay Bhawan**” was attended by 300 members of the organization. The leaders of AIBPARC state committee and also the President and the General Secretary of AIBPARC remained present.
- 2) **Com. D.S. Bhadauria**, the Chairman of Reception Committee, welcomed the members coming from different parts of the country, the guests and leaders of AIBPARC to the conference.
- 3) **Com. N.K. Pareek**, General Secretary, AICBROF, in his introductory address informed the house that the organization had 19 affiliates across the country and the total membership was more than 6,000. He narrated in brief the different successes which the organization had achieved at Bank level. He thanked the AIBPARC leaders for clinching different issues at the national level.
- 4) **Com. A.K. Nagar**, President, AICBROF, heartily welcomed Com. K.V. Acharya, President, AIBPARC, Com. Suprita Sarkar, General Secretary, AIBPARC and Com. Manoj Wadnerkar, the General Secretary of the serving officers' organization affiliated to AIBOC at Central Bank of India and observed that their presence was indicative of their love and affection for AICBROF. He congratulated Shri Bhadauria, the Chairman of the Reception Committee and his devoted team for organizing the boarding and lodging arrangements for a large number of delegates and observers.
- 5) **Com. Manoj Wadnerkar**, General Secretary, AICBOF, being accompanied by senior office bearers of the organization, attended the General Body conference. In his address, he complimented the leaders of AICBROF who had played remarkable role in yester years to build up the movement of officers in the Bank; he promised that the organization of serving officers would faithfully carry on the legacy and the baton which has been handed over to him; he offered a contribution of Rs. 1.51 lakhs for successful holding of the conference of Retirees and assured all types of co- operation to the retirees organization affiliated to the AIBPARC at Central Bank of India.

6) **Com. Suprita Sarkar**, General Secretary, AIBPARC, complimented AICBROF for the excellent contribution of its leaders to the collective wisdom of AIBPARC and he also thanked the members present in the house for making the conference a really colourful and participative assembly of Retirees. He narrated in brief the landmark victories and successes which AIBPARC had registered since its formation. He appealed to the membership to respond to any call for struggle given by AIBPARC to achieve Pension Updation and medical insurance coverage at affordable rates.

7) **Shri B.R. Ramakrisna Naik**, Regional Head, Bhopal, narrated in brief the improved performance of the Bank in Bhopal zone and gave the assurance to all the retirees that he was always available for any problem faced by the senior citizens of the Bank at any point of time and he was ready to help them in all possible manners.

8) **Com. K. V. Acharya**, President, AIBPARC recalled his long association with leaders like Com. R.C. Agarwal, Com. A.K. Nagar and Com. N.K. Pareek who had fought out valiantly against lot of victimization which came upon the members and the leaders in past. He narrated in detail the story behind the successful resolution of the issue of 100% DA neutralization; described the latest position of the ongoing M.C. Singla case pending before the Supreme Court and spoke in details on the Regulation 35.1 – Appendix 1 of BEPR (1995). He was emphatic in his assertion that AIBPARC will fight to the end to achieve Pension Updation for Bank Retirees and he criticized IBA for floating certain astronomical figure as cost of Updation.

9) **Shri Vivek Pandey**, President , AICBOF, **Shri Anil Thakur**, Treasurer, AICBOF, **Shri Ambrish Nanda**, General Secretary, MPCBOU, Bhopal and **Shri B.S.
