The magnificent Swami Vivekanand Auditorium of MIT World Peace University had a festive look in the afternoon of 12th April when a stream of humanity started flowing into the hall from different parts of the city. devotion of nearly 50 volunteers to make the event a perfect and a completely flawless one is really unparalleled. Nearly 200 delegates assembled from different parts of the country. The attendance in the inaugural session was very near to 600. The presence of a good number of retired executives and lady members is worth mentioning. The Retirees shouted in one voice " We demand pension updation as per provisions of BEPR (1995)."

The highlights of the inaugural session are mentioned hereunder:

- * Com. P.S. Patki, General Secretary, delivered the welcome address. He narrated in brief the aims and purposes of the formation of the Federation and its long journey for more than 12 years in course of which several remarkable benefits in favour of the Pensioners and the Retirees had been achieved.
- * The website of the organization was launched by Shri Satish Marathe, the Director on the board of RBI in the midst of thunderous applauds.
- * Shri Satish Marathe, the Chief Guest, in his inaugural address recalled with fondness his tenure at Bank of India and he provided an overview of the Indian Economy and the Banking sector. He paid rich compliments to the Retiree organizations of the Banking Industry and preferred a separate consultative forum for them. He expressed serious concern for the cyber frauds to which the senior citizens are becoming increasingly vulnerable.
- * Com. Suprita Sarkar, General Secretary, AIBPARC, complimented FOBOIPARA for its invaluable support both intellectual and organizational to enrich the functioning of AIBPARC. He exploded the myths created by the adversaries in regard to Pension Updation by explaining different provisions of the 1993 Pension Settlement and BEPR (1995).
- * Com. K V. Acharya, President, AIBPARC and Joint Convenor, CBPRO in his hour-long speech dealt at length the untiring efforts of AIBPARC in escalating all the issues including the demand of pension updation and also the successful resolution of several issues which remained pending for several decades. He explained in details the implications of Regulation no 35.1 & 56 which supported two things- periodical updation of Pension along with the each wage revision settlement and also that our Pension Regulations are guided in letter and spirit by the provisions of Central Government Pension rules. He rejected the Idea of the so- called "huge cost" in allowing pension updation as is being propagated by a section of people and observed that it was a total myth.
