Dear Friends,

You are all aware of the fact that the First General Body of our Confederation took place at Delhi in November, 2012 and on expiry of three years, it would be due in November, 2015. The meeting of the Governing Council held at Chandigarh on 14th July, 2015 decided to hold the General Body in Kolkata on **16th November, 2015**. Formal notice for the General Body will be issued on a later date by furnishing the agenda items, venue, time schedule and other relevant particulars. As large number of delegates is expected to come from different parts of the country, we are notifying the dates beforehand so that purchase of tickets can be conveniently done and we are also stating the provisions of the constitution of our organisation so that each affiliate can have an idea about its entitlement to the number of delegates.

3. As regards number of admissible delegates for each affiliate, we quote hereunder the relevant provision of the constitution:

Each affiliate shall be required to nominate members to the General Body of the Confederation on the basis of (as per amendment to constitution passed in the First General Body held in Delhi) one member for every 200 primary members subject to a minimum of 2 and maximum of 20. For this purpose, membership less than 150 shall be ignored and above 150 shall be taken as 200.
