We are very hopeful of Positive developments in the Meeting slated for 22nd July so that Justice is rendered to Bank Pensioners and Retirees.


We once again Thank You and IBA for enthusing us by ushering in a New Era of Resolution of the long pending Issues of Bank Pensioners and Retirees.
