Dear Comrade,

**Sub: Meeting between the members of the Committee constituted by IBA and representatives of various Constituents of UFBU on issues related to Pensioners and Retirees held on 22nd July, 2021.**

We have come to know that the representatives of Officers organisations and Award Staff Unions met separately through video conferencing the members of the Committee, headed by The MD & CEO of PNB. We studied the communications issued by the respective organizations. Naturally some points had been common while there had been differences too.

We note hereunder various issues of Retirees which were represented by different organisations. The demands placed by the said organizations include inter alia, Pension Updation for all Retirees in line with RBI model, efforts to obtain immediate clearance of the issue of improved Family Pension from Government, 100 pc DA neutralization for pre--November 2002 Retirees, one more chance for Pension --option to left out candidates and Resignees, eligibility for Pension on completion of 20 years of service, immediate increase in ex- gratia to Pre--01.01.86 Retirees, increase in the quantum of Pension on completion of 80 years, 90 years and 100 years etc.

As We have understood, it was a one--sided session to hear the views of Award Staff Unions and Officers Organisations. We express our thanks and gratitude to IBA and all the organizations for taking up the issues of Bank Pensioners and Retirees in a formal platform of negotiation. We believe that the Committee will be sympathetic to the demands and quicken the process of ensuring tangible delivery within a short time frame as majority of Bank Pensioners and Retirees in their Advanced Age are waiting for delivery of justice during their life time.

Comrades, Our efforts will continue to raise the issues at various forums and to escalate the demands for arriving at solutions and try in all possible manners to serve the cause of Retirees.
