Sub : First phase of agitation in the form of Dharna/protest demonstration takes place at Mumbai on 6th June, 2023 at the call of AIBPARC, Mumbai Unit – Retirees of different Banks take part in the “Maha Sangram”.

We have much pleasure to inform that the massive Dharna, organised by AIBPARC, Mumbai Unit at Azad Maidan was a grand show of solidarity and determination of Bank Retirees. Nearly 700 retirees from Mumbai, Pune and Nasik participated in the programme from 11 am to 2 pm. In spite of the extremely adverse climatic condition, the older citizens of the industry made it possible. We convey our sincerest thanks to Com. The gathering was addressed by leaders of our affiliates at Union Bank, Canara Bank, e-Syndicate Bank, Indian Bank, Central Bank of India, Bank of India, Bank of Baroda, Punjab National Bank, Indian Overseas Bank and e-Dena Bank. The principal speaker was Com. P.S. Patki, Working President, AIBPARC. He offered a detailed report on different issues affecting the interest of retirees and narrated the relentless efforts of AIBPARC in resolving the long pending issues.
