S.T hyagarajan, DGS and Mrs. Sumathy Iyer, a Functionary of Canara Bank Retired Officers Association (who kindly facilitated the meeting) met the Hon'ble Chairman of the Committee at Chennai on 12th January, 2022.

Besides handing over the Memorandum, signed by the President and the General Secretary of AIBPARC, the Members of the Committee presented their views on the following lines:

Pension Corpus is substantial and the issue of Updation of Pension can be resolved on the lines of Updation of Pension done by RBI. The team apprised the Hon'ble Member about the cost factor and explained that it would not be a big burden on Banks.
