### AIBPARC/IBA/Consultative Status/Email/2021

The Chairman, Indian Banks Association, Mumbai.

Respected Sir,

### Sub: Request for consultative status of AIBPARC.

This is an issue on which we have been escalating for a couple of months but there has not been any positive response in this regard. In support of our contention, we like to lay before you the following facts for your kind consideration:

- 1) The Ministry of Personnel, Public Grievances & Pension, Department of Pension and Pensioners' Welfare by office memorandum no. 17/3/2021-P&PW (Coord) E7179 dated 6<sup>th</sup> August 2021 has issued a detailed guideline for timely and qualitative disposal of Pensioners' Grievances and spelt out a specific mechanism for the purpose. The spirit and contents of the guideline is highly illuminating for the employees of the Government since it shows a lot of concern and respect for the elder citizens. As the Bank Employees' Pension Regulations are based on the models of Central Govt./RBI employees, the spirit of the guideline is equally applicable for us.
- 2) You will kindly remember that the officials of IBA along with the officials of Ministry of Finance once appeared before the Parliamentary Standing Committee on Personnel & Public Grievances, Law & Justice. During discussions, the Chairman of the Standing Committee impressed upon the officials of Ministry of Finance and IBA the requirement of Banks looking into the grievances of retired employees. The IBA Managing Committee in its meeting held on 23<sup>rd</sup> March, 2009 approved the decision of setting up a Grievance Cell at the Corporate level of each member bank. In pursuance of the said decision, IBA issued a circular on 30<sup>th</sup> March, 2009 for formation of a Grievance Cell at the level of Corporate Office of each Bank to look into the grievances of individual employee or the association of retired employees.

3) It is, therefore, amply clear from the foregoing paragraphs that both Government & IBA have already displayed their anxiety for the quick settlement and resolve of the grievances of retirees at the level of each member bank. From this analogy, we call upon you to please appreciate the need of industry-level negotiation/consultation between IBA and the organisations of retirees on issues which are decided and discussed at industry-level and which have a direct impact on the well being of retirees. When IBA by its own guideline, issued at the behest of the Chairman of a Parliamentary Committee, asked member banks to discuss at corporate level of each bank the grievance propagated by an individual retiree or a retiree organisation, it is very naturally and logically expected that the same spirit and guideline would be followed by IBA itself in respect of negotiation /consultation at its own level between IBA & the Retirees organisations where the issues of retirees are/will be discussed.

We shall consider it a favour if our views expressed above are considered with sympathy and the consultative status be allowed without any loss of time.
