**Sub: Updates on (1) the GST exemption case at Hon'ble High Court of Kerala and (2) M.C. Singla case at Hon'ble Supreme Court.**

1. Yesterday by mobile phones to the leaders of our affiliates and also by WhatsApp messages, the development of the GST exemption case at Hon'ble High Court of Kerala has been made known to members. Further to the said message received from our Advocate Shri V K Prasad, the operative part of the order Hon'ble Court is being informed to you hereunder:

"Admit. Post on 23.02.2026. Till then, there shall be an interim order directing the respondents not to levy GST for the insurance premium paid by the retirees and pensioners of commercial banks under IBA Group Medical Insurance Policy. The above direction is issued in view of the undertaking made on behalf of the appellants that in case the writ appeal is decided against them, the GST component will be satisfied."



Singla case which was listed for final hearing on 15.01.2026 got adjourned for the reason that the Respondent no 4 (PNB) sought for adjournment through their Lawyer. It was a peculiar development. Moreover, the hearing on that date (15th January) also did not cross beyond the listed Number 12. We have to painfully wait for the next date. Let us hope that we will get an early date.
