Dear Comrade,

Sub: Programme of agitation in the first phase is completed – state committees of AIBPARC hold massive Dharna / Protest demonstration at State capitals and other important places in the months of May & June,2023 – the second phase is to commence from July ,2023 onwards .

We have much pleasure to convey that our state committees have very successfully organized Dharna /Protest demonstration in the following places:

1.Bengaluru 2. Patna 3.Hyderabad 4.Ranchi 5.Guwahati 6.Bhubaneswar 7.Bhopal 8.Jaipur 9.Kolkata 10.Thiruvananthapuram 11.Mumbai 12.Vijayawada 13.Chennai 14.Puducherry 15.Lucknow . We are expecting that Dharna will be organized in three more places within one week. It may please be noted that Delhi has been kept outside the list of places where Dharna will be held because the centralised programme at the end of the year will take place at the national capital in case of necessity.

• We have issued separate circular after each Dharna and members have been apprised about details of such programmes. It is worth mentioning that all the programmes have been highly participative and the senior citizens have braved out extremely hot and humid climate and in some cases rains and hail storms to ensure their attendance and participation in such programmes. The Secretary/President of each state unit on conclusion of the Dharna has sent a memorandum to The Secretary, DFS, MOF,GOI and The Chairman, IBA. The anguish of the senior citizens has been made known to all concerned and we expect that the grievances will be taken note of and necessary steps will be taken to resolve the issues.

• The meeting of the Governing Council held on 18<sup>th</sup> April,23 decided to continue the agitation in an on –going manner till the grievances of the Retirees are redressed. In our circular no. 25-23 dated April 24,2023, it was made known to all our members that on-line memorandum (copy will be prepared by the central office) will be sent by individual members belonging to different affiliates to Hon'ble Union FM, Secretary, Ministry of Finance, GOI and also to The Chairman, IBA to ventilate our legitimate demands and claim quick resolution of the pending issues . Members are well acquainted with the procedure since they have taken part in such sort of agitation programmes through electronic media twice in the past.
