Sub: Meeting of CBPRO to be held at Delhi on 11th July, 2024 to take stock of the entire situation prevailing in the industry and to decide the future course of action.

1. We like to convey to all concerned that the above meeting will start at 10 am at the Heinz Auditorium, Tourist Hostel, Delhi YMCA (gate no 1), Jai Singh Road, New Delhi with lot of business to transact. The formal invitation/notice has been sent to the Constituents of CBPRO stating therein all relevant particulars.

2. As the meeting of the Apex Level Retiree Organisations is going to take place at a time when the elections of Lok Sabha have been over and Government has been formed at the Centre, We do hope the meeting will make threadbare discussion among all the Constituents of CBPRO and chalk out the road map for future course of action with Unity and Solidarity.

3. AIBPARC will be represented by the Senior leaders, The President, The Advisors, The Working Presidents, The Senior Vice Presidents, The General Secretary, leaders of Delhi Unit as organizers and Special Invitees. Similarly, The Federation of SBIPAs will be represented by Their President, The General Secretary, and several senior leaders as also General Secretaries of RBONC, AIRBEA, FORBE and AIBRAF as Special Invitee. All Constituents of CBPRO will be attending with their Senior leaders.

4. The first half of the meeting (From 10 am to 2 pm) will be utilised for holding the CBPRO meeting.

The Second half (From 3 pm to 5 pm) will be utilised by the senior leaders of AIBPARC present in the occasion to exchange views on the present situation of the Group Medical insurance scheme for Bank Retirees and other issues and to chalk out the future course of action.

During the same period, the office bearers of our Delhi State committee will also discuss and decide how to implement the various programmes of action envisaged by CBPRO/ AIBPARC in days to come in Delhi which is the epi -centre of Action Programs.

5. Comrades, we expect it to be an eventful day and all the decisions and outcomes of various meetings will be made known to you by circulars.

6. Last but not the least, the General Secretary of AIBRF, Shri S.C. Jain has called a meeting of the Apex Level Retiree Organisations at Delhi on 19th June, 2024 to form another Coordination ignoring our request on numerous occasions to strengthen CBPRO consisting of Major Apex Level Organizations. Hence, we have conveyed to Shri Jain well in advance that AIBPARC will not be attending the said meeting of AIBRF because it was nothing but a duplication of the Co- ordination which already exists. Still, we noted with surprise that in the draft declaration which was stated to be signed by various organisations on the day of the meeting, the names of AIBPARC and that of the Federation of SBIPAs and other Constituents of CBPRO are appearing. Today we have again written a letter to the General Secretary of AIBRF that such things would not at all look right and decent by the standard of fairness in the functioning of the organisation requesting to desist from creating Confusion in the name of Coordination.

We sincerely hope that AIBRF will join CBPRO again to which they have been cordially invited and also attend CBPRO Meeting being held in New Delhi on 11th July, 2024.
