**Sub: Documents mailed by you in connection with your proposed Delhi meeting on 19th June,2024.**

Although we have conveyed to you well in advance about the non- participation of AIBPARC in the aforesaid meeting on grounds elaborately explained in several letters, we note with dismay that the name of our organisation is still appearing in the list of organisations appearing to have accepted your invitation. An organisation which has already conveyed its strong reservations about the necessity to hold such meeting creating confusion in the name of Coordination and

hence conveyed to you our decision to stay away from the meeting well in advance. Despite this, your mentioning in the list the name of our organisation, by all fairness of organizational principles is not correct and we feel that you are adding more confusion In the minds of Pensioners and Retirees.

More interestingly, the name of our organisation is again appearing at the bottom of the declaration conveying the formation of " UFBRO\*" you want to make. We do not subscribe to your formation of UFBRO at all since it is a duplication in the name of creation of co- ordination which already exists as CBPRO and to which you had once been a party and left the same on your demand of making you the Sole Convener which was not acceptable to other constituents CBPRO.

We once again request you not to involve the name of our organisation on papers to which we do not subscribe. **At same time we once again request you to make AIBRF as a Constituent of CBPRO again and request you to attend CBPRO Meeting scheduled for 11th July 2024 in New Delhi** and help further strengthening the Bank Pensioners and Retirees Movement. We also refer to our President K V Acharya's telephone to you on 17th June 2024 in this regard.
