3. Programme at Agartala

We have pleasure to convey that a well-attended protest demonstration was organized at **Paradise Choumohani**, **Agartala on 31**st **July**, **2025** at the call of CBPRO/AIBPARC. A large number of Pensioners and Retirees from SBIPA, TGB and AIPNBPA took part in the demonstration. The weather was inclement but it could not diffuse the enthusiastic spirit of the senior citizen of the industry. Initially the attendance was 125 which gradually got doubled at noon. The presidium was formed with **Com. N.C. Banik**, **Com. S.K. Debbarma and Com. S. Bhattacharyya. Com. Mihir Ranjan Das**, Secretary, Agartala circle, AIPNBPA spoke at length on different aspects of Pension Regulation, the recommendations of the Pay Commission, the financial condition of the senior and super senior citizens of the Banking Industry and the immediate need for allowing updation of pension. **Com. C.K. Taran** of TGBRA also emphasized on the need of pension updation and called upon the Banks to bear the cost of premium of the health insurance of the Retirees. **Com. Barik**, the zonal Secretary, FSBIPAs, spoke on the urgent need of pension revision, restoration of pension after 10 years etc. **Com. S.K. Modak** highlighted the significant contribution of the Bank employees in building of the nation and demanded that the welfare of the retired employees should be attended to. **Com. S. Dutta Majumder** of FSBIPAs stressed on the need of maintaining liaison with UFBU and he expressed concern for the employees under NPS and greeted the conference.

It may please be noted that the Government did not allow the permission to hold Hunger Strike by the senior citizens and as a result, the protest demonstration took place at the call of CBPRO.
