Sub: Decisions taken at the meeting of Presidents and General Secretaries of affiliates of AIBPARC held at Hyderabad on 25th November, 2022.

The above meeting took stock of the present situation and discussed all issues which are relevant to the holding of the 4th Triennial general body conference to be held at Bengaluru and adopted the following decisions:

- 1. The number of admissible delegates and observers for each affiliate has been decided and the same has been conveyed to the General Secretaries in an annexure which was placed in the meeting.
- 2. The number of delegates and observers, as discussed and agreed upon in the meeting, has been determined on the strength of membership as on 31st March,2022(on which affiliates have paid subscription) .The incremental membership has also been noted for the purpose of computing the total membership of the organization as on date.
- 3. This has been decided that each affiliate will pay Rs.1000/- per delegate / observer and the payment will be made before holding of the 4^{th} GB.
- 4. Discussion has taken place on Resolutions on Constitutional amendments. Very soon, circular notifying such amendments will be issued to all members of the Governing Council and also to members of all affiliates.
- 5. Affiliates are earnestly requested to send the names of delegates and observers of each organization at an early date. The number should correspond with the annexure already provided in the meeting.
- 6. The dates and venue of the 4th General Body Conference have already been circulated. This is expected that booking of tickets and arrangement for lodging are being done by respective affiliates. The formal notice with greater details of information will be issued soon.
