Dear Comrade,

Sub: A gentle reminder to all Affiliates and constituents of CBPRO about the tasks to be done to make the Dharna programme of 22nd February, 2024 at Jantar Mantar, Delhi a massive success.

- 1. We shall have to assemble at the above venue and date at10.00 am to ventilate our grievances and demonstrate our anguish before the Government for non-fulfilment of our long pending demands which include, inter alia, the Pension Updation, Special Allowance for Superannuation Benefits, Medical Scheme/ Medical Insurance Scheme, and several other vital issues. We have described in detail in our previous circulars about the issues. The Leaders of the Constituents of CBPRO will address the gathering. We have requested All Apex Level Bank Pensioners and Retirees Organisations to join us and speak in one voice.
- 2.The General Secretaries of all our affiliates will again issue advisory to their organisational set ups at Delhi and adjoining States to mobilize the members stationed in and around the National Capital at the Dharna programme. Our Delhi state unit has been holding meetings to make necessary arrangements and mobilization of members. The local leaders of all affiliates of AIBPARC may be advised to keep in touch with the State Secretary, Com D.K. Hans and Coordinate with all CBPRO Constituents.
- 3. The members of the Governing Council have already been advised to attend the Dharna programme and also the GC meeting for which separate notice has already been issued. If any GC member cannot attend for compulsive reasons, the vacancy in attendance may be filled up by substituted office bearers and the General Secretaries of all our affiliates may please take care about this aspect.
