Sub: 5th Triennial General Body Conference of AIBPARC to be held at Ernakulam on 28th & 29th April, 2026.

Ref: Notice issued on January 23, 2026 through Circular no 07-26.

Further to the contents of the above circular, we convey hereunder some more information which are pertinent to the holding of the 5th Triennial General Body Conference:

1. As per the amended provision of Rule no: 3.1 (a), of the Rules and Regulations of the Society:

" Each Affiliate shall be required to nominate members to form the General Body of the Society on the basis of 1(one) member for every 200 primary members of the Affiliate subject to a minimum of 2 and maximum of 30. For this purpose, membership less than 50 shall be ignored and above 150 shall be taken as 200.

2. As per practice followed by AIBPARC in all the previous Triennial General Body Conferences, this time also certain number of Observers from each affiliate will be allowed to be present in the Conference. The number of such observers from each affiliate shall not exceed 50% of the total number of nominated delegates.

3. A meeting of the Presidents and the General Secretaries of each Affiliate will be held one month ahead of the General Body for which a separate notice will be issued well in advance to discuss the issues like Resolutions and constitutional amendment (if any) to be placed in the General Body, fixation of Delegate Fees, taking stock of the preparation of the GB and all other related issues.

4. The last meeting of the Governing Council of AIBPARC for the present term will be held at Ernakulam on 27th April, 2026 to approve the Report of the General Secretary which will be placed before the Business session. A separate notice will be issued for the purpose.
