Dear Comrade,

Sub: Provision of extended window for left out Retirees to re-join the Group Medical Insurance Scheme for Retirees for the year 21--22.

Please refer to our Circular no 80--21 issued on date being a letter written to IBA with request to provide the same.

In this context, We have come across a circular already issued by one of the Banks wherefrom We learn that National Insurance company Ltd by a communication dated 28.10.21 has already indicated that they are providing the extended window till November 30, 2021. The principal terms and conditions, set for the purpose are:

1. It will be a one-time exercise.
2. Only the Retirees who were covered under GMISR upto 31.10.21. will be eligible to avail the facility.
3. The cover of medical insurance will commence from 01.12.2021 instead of 01.11.2021.
4. There will not be any pro-rata reduction in the premium.

All our Affiliates are requested to take up the issue with respective Banks immediately if such circular has not been issued because it is reasonably expected that uniform advice has gone from NICL to all the Banks.

This is also necessary to ensure that the information reaches the left-out Retirees who are, otherwise, interested for renewal.
