Dear Comrade.

Sub: Contempt petition (Civil) no: 1798 of 2018 in SLP(C) no: 39288 of 2012 in the Supreme Court of India. -- Government Official swears an affidavit in regard to date of implementation of Pension Regulations in RRBs --a real victory for RRB Retirees and employees.

In an additional Affidavit, sworn by the Under Secretary, DFS, MOF, GOI, it has been said inter alia:

"To implement the Pension Scheme in respect of the employees of the RRBs w.e.f 01.11.1993, in terms of Memorandum of Settlement dated 29.10.1993 applicable to NCBs and to pay consequential arrears of Pension/ Family pension."

At the conclusion of the said Affidavit, it has further been told:

"In view of the above, it is submitted that there would be no merit in the Contempt Petition and the same deserves to be dismissed."

We can reasonably expect that Law will take its natural course of action and the victory will ultimately be with our brethren in the RRBs who had been fighting a great battle against the discrimination in regard to the date of implementation of Pension Regulations.
