We have been requesting you to take up the pending issues of Bank Pensioners and Retirees with IBA. We wish to place it on records that UFBU leaders have been quite obliging in this regard.

As a result of the persistent efforts and follow up by UFBU and its leaders more particularly Com CH Venkatachalam, who took pains to meet the CMD of United India Insurance Co. Ltd., another option to left out Retirees to join Medical Scheme 2019-20 could be clinched.

We whole-heartedly thank you and other leaders of UFBU for the help in getting the option to join IBA's Group Medical Scheme for Bank Retirees.

We also request you to continue your efforts to clinch the following important issues along with the impending Bipartite Settlement:

- 1. Banks to bear Medical Premium, pending which extend substantial subsidy
- 2. 100% DA neutralisation to Pre-November 2002 Retirees
- 3. Uniform 30% Family Pension at par with Government/RBI Family Pension Scheme (Regulation 56)
- 4. Updation of Pension as provided in Bank Pension Regulation 35(1) without any dilution (read with Regulation 56)
- Reckoning of Special Allowance for Superannuation Benefits viz, Pension and Gratuity w.e.f. 01.11.2012. This is supported by principle laid by the Judgements of Hon'ble Supreme Court and Hon'ble High Court of Kerala in case of Corporation Bank.

We are confident that the dynamic leadership of UFBU will leave no stone unturned to clinch these demands of Bank Pensioners and Retirees to their satisfaction.

We can assure you to join in your all action programmes for clinching a respectable Bipartite Settlement.
