You might have received by now letter no: 4/1/1/2022--IR dated 5th October, 23 sent by DFS, MOF, GOI on the above referred subject. This is expected that you would be advising Banks soon about implementation of the same.

We request you earnestly to kindly issue the advice addressing the same to all Banks which had been parties to Pension Settlement of 1993.

As in previous occasions, if the letter is primarily addressed to Public Sector Banks only, the Retirees of the following category of Banks will be left out and that is not desirable.

- 1. The Private Sector Banks which are still member banks and where Retirees are covered under provisions of Bank Employees Pension Regulations (1995).
- 2. The Retirees of such Banks who are covered by provisions of Bank Employees Pension Regulations (1995) but at present the said Banks are merged with such Banks which are not parties to Bipartite Settlement viz LVB merged with DBS Bank and BORL merged with ICICI Bank.

Hence to cover the genuine interest of all who are eligible to get the benefit, the advice may please be addressed to All the Banks which had been parties to the pension settlement of 1993.
