**Protest Dharna and Demonstrations in respect of Bank Retirees Pending  
Issues  
Request for Support**

Coordination of Bank Pensioners and Retirees Organisations (CBPRO) is organising Protest Dharnas and Demonstrations in State Capitals and important Centers during the month of November 2019 urging the Government and IBA to resolve the following long pending Issues of Bank Pensioners and Retirees.

1. Early Wage Settlement for Serving Officers and Employees including Bank Retirees issues.
2. 30% Uniform Family Pension at par with Government and RBI Family Pension.
3. Updation/Revision of Pension to all Banks Pensioners.
  
4. absorption/Reimbursement of Medical Insurance Premium towards IBA's Medical Insurance Scheme for Bank Retirees by the Banks and alternatively introduce Health Care Scheme for Bank Retirees on the lines of CGHS.
5. 100% DA Neutralisation for Pensioners who retired prior to November - 2002.
6. Reckoning of Special Allowance introduced w.e.f 01.11.2012 for the purposes of Computation of Pension and Gratuity.
7. Scrapping of New Pension Scheme by extending existing Pension Scheme to all Employees and Officers irrespective of their date of joining service.

**Dear Comrade**, as the above issues are agitating all of us and though all the Bank Pensioners and Retirees Organisations had organised several Action Programmes still remain unresolved. We believe that our sustained agitations and action programmes will contribute to successfully clinching our long pending and legitimate demands at Industry level.

The Bank Pensioners and Retirees Organisations have been pursuing the issues actively with the UFBU and in turn they included the Bank Pensioners and Retirees issues mainly Improvement in Family Pension and Updation of Pension in their Charter of Demands for Wage Revision. The UFBU have been trying to sort out the issues during the ongoing Wage Negotiations.

In view of the above we have decided to organise Dharnas and Demonstrations in support of our Demands and also display solidarity with the UFBU in their Struggle on our Issues along with their issue of Wage Revision.

We request Your Organisation, AIBRFs Support for the Dharnas and Demonstrations being organised by CBPRO by calling upon Your Members to join the Dharna and Demonstrations in all the Centres. We also request Your Leaders to address the Bank Pensioners and Retirees in such Dharnas and Demonstrations.
