Sub: GMISR for the year November 2025 to October 2026.

Ref: Circulars issued by AIBPARC on Health Insurance as on very recent dates.

Members are all apprised of the steps taken by the organization in regard to the implementation of the order of interim injunction passed by the Hon'ble High Court of Kerala dated 17th October, 2025. Different affiliates which have been the Petitioners have served the Notice to respective Banks and AIBPARC has served the Notice on the Chairman, IBA and different Respondent Banks. Next date in respect of All Petitions filed by our various Affiliates and by the Apex Organisation AIBPARC is posted to 31st October 2025. The Interim Injunction is in operation. The Banks as Respondents are obliged to abide the Hon'ble High Court Interim Injunction Order. We have noted the response pattern of IBA and different Respondent Banks. In consultation with our Advocates, we shall decide our next course of action.

Intervening holidays due to Festival on different days and dates in different states along with Sundays and Fourth Saturday created anxiety for all of us in regard to the Time-line for submission of consent for Medical Insurance Policy.

Different Banks have fixed different dates for submission of Consent Forms by the Retirees. In some Banks, the dates have already gone and several Banks have fixed the dates on 23rd /24th/27th October, 2025. We request our intending members to be very cautious about the dates of respective Banks and they should not miss the dates to give their consent as per the procedures and systems followed by the respective Banks for availing the Medical Insurance Policy for the year 2025-26. At the same time, we are also closely following up all the concerned matters and are in touch with our Affiliates regarding the position in their respective Banks and shall communicate /advise the developments to our members so as to ensure availment of Medical Insurance Policy on time.
