Respected Sir,

Sub: " DA scheme for all Pensioners to be at the uniform index of 8088 points."

1. In the Minutes of Discussion held on 8th March, 2024 between IBA and the workmen organisations, we find a list of identified Residual Issues which are to be amicably resolved within a period of maximum 6 months i.e. within 8th September, 2024.

2. At point no 11 of the said list, it is written that the " **DA scheme for all Pensioners to be fixed at the uniform index of 8088 points** " but from the proceedings of the Bipartite talks held on 26.08.2024, we learn "that the issue needs further discussion before any view can be taken".

In light of the above situation, we like to convey that CBPRO (of which AIBPARC is a major constituent) in its letter dated 17th August, 2024 drew your attention to the fact that that an artificial classification has been created between the Pre and Post 01.11.2022 Retirees by paying DA under two different CPI series after implementation of the 12th Bipartite Settlement/9th Joint Note and it is got to be removed.

4. You will appreciate that after a long struggle of more than two decades, the uniformity of DA compensation was arrived at in recent times and we should not do anything to distort it once again. The issue needs an early attention so that issue can be resolved within the definite time frame of 8th September, 2024.

5. We are certain that the Pre-November 2022 Pensioners will not be subjected to discrimination again.

We are waiting for a sympathetic consideration from Your Goodselfes.
