Although the Interim order is very much in operation, we wish to express our utter dismay and anguish that the IBA maintained a rock like silence (at least as it appeared on the surface) and same was the condition of the Respondent Banks which continued to go on collecting the annual premium with GST.

We have immense happiness to note that at least one PSB ( IOB) till now has abided by the Order of Hon'ble High Court of Kerala and issued a circular on 23.10.2025 in which the Bank communicated to all concerned that as per the direction of the Court the Health Insurance Premium would be collected without the GST and the GST amount already remitted by those Retirees for renewal will be refunded within a stipulated date and now onwards up to an extended date, the annual premium will be accepted without GST.

We are sure that you have already got this information before our letter reaches your office.

Can we now very reasonably expect similar such action from all the Respondent Banks? Though the Hon'ble High Court Order should be abided by the Banks, still as we understand that some Banks are waiting for a uniform Advisory of IBA, we request you to do the needful immediately as the Time-line set for availing Medical Insurance is very narrow and stiff. We request you to apricate the natural anxiety of Retirees, many of whom are very aged and are not Tech -savvy and do not know digital operation. It is the responsibility of the Banks and IBA to ensure implementation of the Hon'ble Court Order in a hassle-free manner.

We wish your personal intervention in the matter.

We are endorsing the copy of the letter to the MDs of all the Respondent Banks.
